# A. Midtown on Haggerty PUD.

Trustee Berkheiser said at the April Township Board meeting he voted against the Motion to approve the First Amendment to PUD Agreement for Midtown on Haggerty Planned Unit Development. He would like to reconsider that vote.

**MOTION** by Berkheiser, supported by Weber, to reconsider the First Amendment to the PUD Agreement Midtown on Haggerty.

**MOTION** by Weber, supported by Gray, to approve an amendment to PPU#20-02, a PUD application for a first amendment to Midtown on Haggerty, a commercial development by Midtown on Haggerty LLC (Steve and Spencer Schafer of Schafer Development) consisting of approx. 20,000 sq. ft. of retail within three existing/constructed commercial buildings, an approx. 103,000 sq. ft. commercial building expected to be occupied by Kroger, and a Kroger fuel center including canopy, 7 pumps, and staffed service kiosk, upon approx. 25 acres on the west side of Haggerty Road north of 14 Mile Road. The Planning Commission's recommendation of approval is based on a finding that the amended PUD application satisfies the requirements outlined in Article 38 of the Commerce Township Zoning Ordinance; that the proposed development is consistent with the goals of the Commerce Township Master Plan; that the project will offer recognizable and substantial public benefits proportionate to the deviations from the Zoning Ordinance being requested by the developer, most notably the inclusion of the Kroger fuel center; that the PUD development agreement achieves the goals of both the Township and the developer to create a high quality commercial development that the Planning Commission is confident can be approved in a future PUD site plan; and that Steve & Spencer Schafer in partnership with Kroger and with Neil Fetter and his family will capably serve as the master developer with unified control over the entire Midtown on Haggerty project.

This recommendation of PUD approval is conditional upon the following:

- 1. Approval by the Commerce Township Board of Trustees of the PUD's development agreement and development plan;
- 2. A fully-formed development agreement to be reviewed by both the Planning Department and Township Attorney prior to consideration by the Township Board. Said development agreement to incorporate the direction of the Planning Commission, particularly as it relates to commitment of recognizable public benefits;
- 3. A detailed PUD site plan to be reviewed and approved by the Planning Commission subsequent to Township Board approval of the PUD, with the PUD site plan to include (but not be limited to):
  - a. A detailed signage plan for all proposed wall signs, fuel center canopy signs, and freestanding signs both new and existing, with the preliminary details provided as exhibits to the development agreement;

- b. Detailed building elevations for the Kroger building including upgrades as directed by the Planning Commission, with the preliminary details provided as exhibits to the development agreement;
- c. An outdoor storage/sales/display plan clearly defining the location, duration, and material type;
- d. Inclusion of the proposed sidewalks described within the PUD agreement Page 7 PPU#20-02 Midtown on Haggerty PUD AMENDMENT Planning Department PUD Review Township Board meeting on April 8, 2025
- 4. Approval by the Road Commission for Oakland County (RCOC) for all public road improvements within their Haggerty Road right-of-way, most notably the new traffic signal at Haggerty Road & Midtown Avenue recommended by the Township's Traffic Engineer;
- 5. Adherence to the findings & recommendations of the revised/updated traffic study by the Traffic Engineer, including those recommendations upon private property specifically the recommendation of a dedicated right-turn lane along Spring Vale at Haggerty;
- 6. Significant changes to the layout proposed in the development plan may require approval by the Township Board of an amended development plan;
- 7. (any other conditions the Planning Commission deems necessary as part of PUD approval).

## Discussion:

Trustee Sovel would like to include a conditional amendment to the Motion. The Kroger store signage must refer to "Commerce Township" and not any other community.

**MOTION** by Sovel, supported by Gray, to amend the Motion to include condition number 8. That all Kroger signage shall refer to "Commerce Township" and no other community.

## **ITEM 6:5-13 NEW BUSINESS**

A. Part Time Social Media & Marketing Associate Job Description Katelyn Massey, Human Resources Director, presented the job descriptions for the Board's review.

Trustee Berkheiser feels we need this service but does not feel it needs to be a Commerce Township employee. This could be contracted out to a company that is knowledgeable and provides this type of service.

Katelyn Massey is not aware of any contractors that can do this but she will investigate it.

Trustee Sovel said he thought Ben Sebrowski, IT Director, came to the Board a few years ago asking for a part time person to help him with social media. (note: the part time person was not hired for social media).

Trustee Weber does not see how we can find a part time person to do what we are asking. Why not take both positions and combine it into one full time position?

Trustee Long said there are a vast number of social media firms that we could use in place of hiring a part-time employee.

Clerk Creech feels we need someone in house. We need someone who will not only work on social media but attend our Directors, Attorney, and Engineer's meetings in order to place important information on our website, among other things.

Trustee Sovel recommends forming a workgroup to do an analysis on what is best for the Township and bring back their findings to the Township Board.

**B.** Assistant to the Director of Senior Services Job Description Revision Emily England, Parks and Rec/Senior Director, said this is for an existing full-time position that recently became vacant. She wants to revise the title and add some duties to include both senior services and Parks and Recreation.

# D. Teen Volunteer Policy – Proposed Amendment

Alyson Lobert, Library Director, said the Commerce Township Community Library's Teen Volunteer Policy was approved by the Commerce Township Board of Trustees in January, 2025. Recently, I was made aware of the work permit requirement in Public Act 90 of 1978, the Youth Employment Standards Act (YESA), which necessitates minors having a valid work permit for volunteering as well as for paid work. As a result, I recommend two changes to the Teen Volunteer Policy: changing the minimum age to volunteering to 14 (as this is the youngest a minor can obtain a work permit) and specifying the work permit requirement in the policy. Both changes are reflected in the enclosed draft.

Treasurer Phillips –

Refunding 2016 Capital Improvements or Bonds savings by reissuing a lower amount of debt. If any of the bonds that mature after December 1, 2025, which is our next principal payment, bonds from 2026 through 2038 can be called when I make that payment. If I were to call the 1.74 million that is due in 2038, I would save \$1,131,000 in interest over the 13 years that those bonds would have been outstanding. She sent this information to Dawn Lund and is waiting to hear back from her to find out if this would change any of her projections on her sewer rates.

Trustee Berkheiser -

- Asked for a follow up on the fence at the cemetery. Clerk Creech said Mark Schoder, Maintenance Director, is obtaining quotes for the fence on the north side of Old Burying Grounds.
- Eagle Project mentioned by Fire Chief Dundas There were approximately 30 adults/Boy Scouts patrolling the Township for 3 hours to take care of approximately 500 fire hydrants in the Township.

# Trustee Weber --

- Please respond to me if you are going to volunteer one hour of your time to staff a Commerce Township booth at the Bicentennial Event.
- We previously talked about our ability to have residents sign up and pay for events online. He would like to continue discussion on having a Township wide process where someone can either reserve the Richardson Center or sign up and pay for any other event. Supervisor Gray said we can discuss this during a Quarterly Discussion meeting. Treasurer Phillips said we currently have a platform for Parks and Recreation and the library. All of this will change because we will not be using G2G Cloud Solutions through Oakland County. Point & Pay (payment software) can handle all online transactions, it is just a matter of setting it up.
