ITEM 3:1-14 BOARD APPOINTMENTS

A. Johnny Walker – Reappointment to the Parks and Recreation Committee for a 4-Year Term Ending February 28, 2029

MOTION by Gray, supported by Creech, to Reappoint Johnny Walker to the Parks and Recreation Committee for a 4-Year Term Ending February 28, 2029.

Discussion: Trustee Weber - Bob Berkheiser asked him to pass on to the Board that Johnny Walker is a valuable member of the Parks and Recreation Committee and he is in support of his reappointment.

ITEM 4:1-14 CONTRACT AWARDS AND AGREEMENTS

A. C&E Construction Grinder Pump Contract Extension

Jay James, P.E. President KER Engineering, Inc., advised the Board the current contract with C&E Construction for installation of grinder pumps within Commerce Township expired at the end of 2024. There is a provision in the existing contract for two (2) one-year extensions, if both parties agree. He recommends the current contract be extended with C&E Construction through the year 2025.

MOTION by Creech, supported by Phillips, to extend the current C&E Construction Grinder Pump Contract through the year 2025. **MOTION CARRIED UNANIMOUSLY**

B. Appraisals for Pontiac Trail and Beck Road Water Main Easement Acquisition

Hans Rentrop, Township Attorney, presented proposals from Stout Risius Ross, LLC; RS Thomas & Associates, Inc.; Integra Realty Resources; and Fuller Appraisal, L.L.C for the acquisition of watermain easements across twenty-one parcels of property involved in the project.

ITEM 4:1-14 CONTRACT AWARDS AND AGREEMENTS (Appraisals for Pontiac Trail and Beck Road Water Main Easement Acquisition continued)

MOTION by Weber, supported by Phillips, to move forward with the low bidders Fuller Appraisal, L.L.C. on the Pontiac Trail and Beck Road Water Main Easement Acquisition at a cost not to exceed \$48,500.

C. Resolution Authorizing Township Supervisor to Sign Documents Relating to the Lease at Log Cabin Drive

Hans Rentrop, Township Attorney, gave an overview of discussion during Closed Session at the December 10, 2024 Township Board meeting.

Supervisor Gray said SBA Steel II, LLC is requesting a five-year agreement with four (4) additional five-year term extensions.

Hans Rentrop recommends a 5-year lease term then re-negotiate the lease payments/terms at the end of the 5-year term.

MOTION by Phillips, supported by Creech, to approve the Resolution of The Township Board of The Charter Township of Commerce Authorizing Township Supervisor to Sign Documents Relating to the Ground Lease at Log Cabin Drive.

A. An Ordinance to Amend Ordinance No. 2.029 to Be Known as Fee Ordinance No. 2.030 Clarification of Water Rates for 2025

MOTION by Creech, supported by Phillips, to Adopt The Charter Township of Commerce Ordinance to Amend Ordinance No. 2.029 to be Known as The Charter Township of Commerce Fee Ordinance No. 2.030, post and publish according to law. **MOTION CARRIED UNANIMOUSLY**

ITEM 6:1-14 PURCHASES

A. Flooring at Fire Stations 1 and 2 – Fire Department

Jim Dundas, Fire Chief, is requesting approval to purchase flooring for Fire Stations 1 and 2 from The Carpet Workroom Inc. at a cost of \$21,555.89.

MOTION by Phillips, supported by Creech, to approve the purchase of flooring for Fire Stations 1 and 2 from the low bidders The Carpet Workroom Inc. (proposal #22800-24 dated 12-3-2024) at a cost not to exceed \$22,000. Funds to come from the Fire Department Budget in the Buildings and Grounds Account.

B. Glowforge Plus Engraver - Library

MOTION by Creech, supported by Gray, to approve the purchase of a Glowforge Plus Engraver from Glowforge (quote #D141278 dated 12-3-2024) at a cost not to exceed \$6,044. Funds to come from, the Library's 2025 budget.

A. Teen Volunteer Policy - Library

Alyson Lobert, Library Director, said the Library Advisory Board recommends approval of the Teen Volunteer Policy.

MOTION by Weber, supported by Creech, to approve The Commerce Township Community Library Teen Volunteer Policy with the employment clause to be suggested by the Township Attorney. **MOTION CARRIED UNANIMOUSLY**

B. 2025 Budget Amendment - Ordinance Department

Supervisor Gray said this is an Amendment for an additional \$15,000 for a full-time Ordinance Manager.

MOTION by Gray, supported by Phillips, to approve an increase from \$110,000 to \$125,000 in the 2025 Budget Amendment – Ordinance Department, for a full-time Ordinance Manager.

Discussion: Trustee Long asked when the Ordinance Officer will start working.

Supervisor Gray answered he will start within 2 weeks.

Trustee Long said ordinance violations are low this time of the year and we could save money by waiting until spring when ordinance violations will increase.

Supervisor Gray said the Ordinance Department has two part-time Ordinance Officers right now. One Officer works Monday and Tuesday and the other works Wednesday and Thursday. They can use another Officer right now because it will take a few months to catch up on the backlog of work and this will give enough time for training.

• Contact Supervisor Gray if there is an item you want on the agenda for the January 28, 2025 Township Board Quarterly Discussion Session.

Trustee Weber -

- The Bicentennial event will be held in June 2025. This would be a good opportunity for the Township to have a tent with placards showing residents what is happening in the Township. Some examples would be: trailway vision, map of the Township that highlights properties that are protected green space, traffic issues, Five and Main Development plans, etc.
- Five and Main is the biggest development coming to the Township. We should hold a town hall to listen to residents' concerns about the Five and Main development. This would also be a great opportunity to promote the positive aspects of the development.

Supervisor Gray-

- There is interest from someone to lease half of the lower floor at the 2019 building. He would like to begin negotiations. It was the consensus of the Board to approve Supervisor Gray's request.
- He is working on an RFP for the Assessing Department. Our contract with Oakland County ends on June 30, 2025. We will spend approximately \$379,000 on the Oakland County Assessing Department. With increases in costs, if we have the same increase as the new Oakland County Sheriff contract, then we will be looking at a \$56,000 increase next year. I am hoping to get the RFP out there by the end of February.
- The Byers EGLE violations are closed out.
- Walled Lake School District approved the School Resource Officer Contract.
- He again asked Walled Lake School District if they are interested in swapping the property they own behind Victory Park. No response yet.
- During the February Township Board meeting he will ask for a budget amendment for the building fund to purchase a new truck for the Ordinance Department.
