Supervisor Gray made a short presentation about Township actions to date regarding the conditions of a home in the Lake Sherwood subdivision.

# **ITEM 2:6-14 PUBLIC COMMENTS**

Supervisor Gray opened Public Comments.

Joel Hamp, 5605 Deerwood, spoke about the situation at the on Deerwood, saying there's drug and prostitution activity at all hours of the day and the police are there all the time. He said people are squatting there while the owner is in jail and one of those people threatened him earlier today.

Joli Hull, 5010 Winewood, spoke about the horrible condition of the property on Winewood. They've endured 2 1/2 years of feral cat smell with urine and feces everywhere. The smell is so bad they cannot use their own yard. It's a health and safety issue for the neighborhood.

Riley Bristow, 5010 Winewood, spoke about the horrible smell, how embarrasing it is, and how you have to run from your car, while holding your breath, directly into the house. She can't even open her windows.

Noah Arbit, resident of West Bloomfield, introduced himself to the board of Trustees and said he is running as a democrat for the 20<sup>th</sup> State House District.

Martha Klemmer, 2884 Tamwood, said the owner of the house on Winewood does not pay his dues or obey the rules. The home is completely unsanitary and the Health Department needs to check that house. Bats and cats are going in and out. We need strength, not a wimpy lawyer.

Cecilia Elliott, 5578 Deerwood, said that she has lived here for 25 years and it's disappointing to have drugs and prostitution in the area and she is worried about her special needs, non-verbal son. They can't use their pool, random people walk through their yard all the time. The cops indicated that at the last OD call, the conditions in the house were worse than expected.

Andy Sarkisian, 3398 Tiquewood, thanked Supervisor Gray for his help with Deerwood. He's lived in the township for 30 years and he loves Lake Sherwood and how active the community is. They love the community because it's away from the city and crime. The Winewood house is a habitual violator and is feeding the cats.

Gary Koch, 2978 Ravinewood, thanked Supervisor Gray for his help. The judge ordered the person on Winewood to stop feeding the feral cats and he has not stopped feeding them and there are 5 junk vehicles parked on the property. It's been almost a year and no progress has been made.

#### ITEM 2:6-14 PUBLIC COMMENTS continued

Craig Lundin, 2961 Barbwood Ct., said he's familiar with the conditions on Winewood and he talked to the wife and did the neighborly thing and offered to help clean up the yard and mow the lawn and the next day he received a restraining order via certified mail. The man on Winewood does not want to participate.

Greg Woelfel, 4911 Winewood, said he put out a feral cat trap and captured 5 feral cats which he took to Oakland County Animal Control. Their policy is to spay or nueter the feral cats and release them back at the same location, which does not help the situation.

Sue McFarland, spoke about the fact this property has been like this for years but it is worse now. The feral cats have reached a completely different level. The cats need to be removed safely. As a homeowner, for her it's been frustrating that there is a certain process that the Township needs to follow which has been very slow. The Township also said the HOA needed to do certain things and the HOA says they've done everything they can. It needs to be a joint effort of some sort. Her concern is this is precedent setting and this thing has been going on for years with no resolution. It's a nightmare and we need to expdite this. Why does is take years to fix? It's garbage.

Thea Vagiates, I live on Deerwood, that house on Deerwood is an active drug house. I strongly support the funding of NET. I support my neighbors comments regarding drugs and postitution, I see it all day and night with young girls going into the house. There's serious safety concerns here.

Mike Loney, 2944 Barbwood, he purchased his house 8 months ago and he sees this as a blatant disregard for the HOA. The stench is so bad he can't even take walks in the neighborhood, now there's no trespassing signs in the yard. This is someone with a total disregard for others. When you go into a community you obey HOA laws.

Teresa Thompson, 3115 Ravinewood, unbelievable to her that it's gotten this bad. She doesn't understand how long things are taking. Are we going to wait until someone drowns in a neighbor's pool or a child is picked up off the street. She commends everyone's patience. She dosen't know who is supposed to take care of this but someone should, we all pay taxes, we all live in the same Township. If you were living next to the house on Deerwood or Winewood, it wouldn't be like this. It would've been taken care of. Why is nobody upset? What exactly are we waiting for? She's mortified, she moved out here to get away from the city. What is taking so long.

Bill Elliott, 5578 Deerwood, lives near the house everyone is talking about. What can we do to protect ourselves? He has a special needs son and a wife and he goes to work every day. That house is rocking and rolling all night long. They moved here to specifically stay away from the nonsense and nonsense has found them. He called 911 today and it took them at least 15 minutes to get here because of traffic. he can't use his pool, there's drug paraphernalia in the road.

Trustee Weber said we hear what you are saying on both Deerwood and Winewood and we sympathize and empathize with you. I take umbrage at the comment that if we were living on the street, it would be fixed tomorrow. We care but we have to go through the legal process. We as a local government can't go and evict somebody, as much as we would like to in certain cases. We have to go through the court system. And, yes, I did not realize the person on Winewood was an attorney, that yes if this is a game, we will play the game. We have our attorney here and we have started the process, the suits are in process, the fines are being applied. We have to do it through that process and if there was a mechanism to go faster, we would go faster. I agree that we did not go fast enough at first, we did not have our ordinance officers in place a few years ago. I commend Supervisor Gray who took the initative to figure out how we can have an ordinance officer and how to actually fund 2 officers, not just to solve this issue on Winewood, which is not an isolated case. There are numerous properties within the Township where people let properties go and we are taking action on those as well. We do hear you, we empathize with you, we understand the urgency, and we are trying to expedite any urgency we can but the process to resolution has to go through the court system and we all know what that's going to be like. We are committed to it and we don't have another mechanism to make a person sell their property or to magically wave the wand and make the person go fix everything they're doing with the cats. I think the opportunity with Animal Control and the Humane Society -I will investigate that. I don't know if there's anything we can do with that or not. But if there's something on that avenue, we'll move with that.

A member of the public asked if the properties could be condemed?

Trustee Berkheiser answered that it is the same court process and it takes several years.

Shahnaz Atchoo, 5565 Deerwood, she has children who are 5 and 6 years old and they can't go outside, there are syringes on the ground. This disgusts her that they can't go outside and ride their bikes. There are hookers and drug dealers coming in and out of the street. It blows her mind that the legal system is this slow in trying to resolve this issue. They've been here 8 years and she's ready to pack up and get the hell out of Commerce because they are not gonna raise their kids with drug dealers and hookers on the same street as them. She's called the Oakland County Sheriff numerous times.

Steve Biebel, 5251 Starwood, said he's the current HOA president, and just wanted to let the Board know that Lake Sherwood has done its part. They've kept track of this house and provided information to the sheriff and they have a long significant history with this guy that's gone nowhere and they understand that government is going to move at the speed of government and they are going to be as patient as they can and do everything they can to help.

Giffels Webster's scope of services include 4 phases: 1) refinement of existing conditions analysis and GIS mapping, 2) public involvement, vision, goals and objectives, 3) Master Plan updates – development areas and future land use map and, 4) a public hearing and adoption.

Trustee Weber (continued) -

- There's a large fund balance in the Building Department, and there are limited uses for it, I suggest that a portion of it be used to waive the fee for the rental inspection ordinance if you register your property in the first 6 months.
- The People's Express contract is up in October.

#### Trustee Berkheiser -

- Asked if there is weekend enforcement of the sign ordinance? Supervisor Gray answered "yes".
- Is there an update for 5 and Main? Supervisor Gray indicated Bruce Aikens will update the Board at the July quarterly meeting.

## Treasurer Phillips-

- The Township audit is complete. Does the Board have any items they would like additional information on?
- The NSF fee pre-printed on the tax bills as \$27.50 is incorrect and we are only charging \$25.00
- Do you want me to send out and RFP for new auditors? Or, negotiate a new 3-year contract with Plante Moran? Trustee Berkheiser asked for a 3-year proposal from Plante Moran.
- I've been looking at a system called Debt Book which manages all the Township's leases and complies with GASB 87.
- Our letter of understanding with PNC expires on 9-22. I would prefer not to do a banking RFP during tax season. I will ask for a proposal letter.
- I was certain someone would ask how much money we've been reimbursed from the HIDTA program and no one did but I have those numbers. We've paid \$5,000.00 in over-time and in 2018 we received \$30,899.00, in 2019 \$37,213.00, in 2020 \$34,964.00, and in 2021 \$24,184.00.

#### Clerk Creech-

• We have an issue with a cemetery in Commerce Memorial. Back in 1985 a family bought 2 lots and then sold one of the lots back to the Township. The information regarding the lot sell back to the Township was not communicated to Huron Cemetery Maintenance. Recently, the family, who originally bought both lots, buried their son in the lot they no longer own. Huron Cemetery Maintenance was unaware that the family no longer owned it. This family has suffered several tragedies in recent years.

- Asked Lt. Reyes if it took officers 15 minutes to respond to a 911 call to a home in Lake Sherwood today? Lt. Reyes said it did not take 15 minutes according to the call logs.
- Asked if the Horse Farm is coming back to the Board? Trustee Berkheiser said the sub-committee is meeting next week.

Supervisor Gray-

- I asked the road Commission to do a study on Loop Road. The project came in at \$3 million. If we use tri-party funds, it will cost us \$427,000.00 out of pocket.
- The second round of ARPA money is coming by the end of July. A resident on Cardinal has asked for new cross-walks with flashing beacons near Dodge Park.
- We have 2 maintenance department job openings and we have received zero applications for part-time summer help. We are still looking for help at the Richardson Center and Molly has an opening in the Treasurer's Department.
- Had a meeting the other day with Spicer and the preliminary budget came in at \$1.5 million. We've removed some of the items to reduce the cost. We are right around \$1.25 million for the project. I've also pushed back the dates on bidding the project out.

Township Attorney Hans Rentrop circling back to the lawsuit we have ongoing with Joseph James vs. James Karol and Christine Karol. Their lawsuit is from when the sign with razor blades was removed by Jay James when he was the ordinance officer. The defendants' attorney has requested to take deposition of Larry Gray and David Scott, as supervisor and ex-officio supervisor. It is our recommendation that they be attended with an attorney to know what is going on in that deposition because it does pertain to Township business. I'm requesting approval for that.
