ITEM 2:11-15 PUBLIC COMMENTS

Supervisor Gray opened Public Comments.

Robert Long 1342 East Commerce Road, Commerce Township, Michigan. He would like to sell hard cider at Long Family Orchard, Farm & Cider Mill. He previously spoke with Hans Rentrop, Township Attorney, about this request and Mr. Rentrop told him there is no provision in Article 6 of the Township Ordinance that addresses small wine liquor license that allows the manufacture and sale of hard apple cider. He is asking the Township if they would discuss this and advise Dave Campbell, Planning Director and Hans Rentrop, Township Attorney of their decision. He is also very concerned with the Township's Master Plan indicating his property is in an area of special concern. In 1968 his farm was zoned single family residential (low density). Supervisor Gray said they will consider his hard apple cider request and he also advised Mr. Long that they are not looking to push the Long Farm out, they are just looking at what could happen in the future when the Long family decides not to farm anymore.

Christine Long, County Commissioner, 1342 East Commerce Road, Commerce Township, Michigan. There is 5 Million Dollars available for all of the senior centers in Oakland County through the American Rescue Plan. The application to receive a portion of this money is due on December 9, 2022. There was 244 Million Dollars of American Rescue Plan Funds for Oakland County. As of today there is 82 Million Dollars left over in the fund that could lead to additional opportunities for Commerce Township. Oakland County passed a billion-dollar budget. The County Commission went from 21 to 19 members. Twenty years ago, there were 25 Commissioners (19 Republicans and 6 Democrats). Today there are 19 Commissioners (13 Democrats and 6 Republicans).

Noah Arbit, Michigan House of Representatives District 20, 2560 Woodrow Wilson Blvd, West Bloomfield, Michigan introduced himself and said he is honored to represent Commerce Township. He is looking forward to working with the Township. He assumes office on January 1, 2023.

Carrie Hancock, 2552 Wixom Road, Commerce Township, Michigan would like to meet with the Township to discuss keeping Windmill Farms in place until the RFP is complete and to discuss the demolition of the farm house. She had 3 contractors look at the house and all 3 said the house was structurally sound. She plans on submitting a proposal to the Township and does not want to see a gap in the services she provides to the community.

Jennifer Saylor 2068 Alsup Ave., Commerce Township, Michigan is in support of Windmill Farms staying open. She is asking the Board to reconsider the actions they took against the farm.

Ms. Yeager, 1990 Birch Ct., Waterford, Michigan is in support of keeping Windmill Farms open. She is asking the Board to rescind the termination agreement and keep equestrian activities at status quo under the direction of Carrie Hancock and extend her lease allowing time for her to submit a proposal. She would like to know who is on the subcommittee and how she can obtain minutes of the meetings.

Karen Mitchel, 2425 Archdale Blvd., West Bloomfield, Michigan is in support of keeping Windmill Farms open. She is asking the board to reconsider the termination of Windmill Farm's contract and accept Carrie Hancock's proposal.

Dennis Kaiser, 1990 Birch Court, Waterford Michigan is asking the Board to hold off on the demolition of the house because he would like to present a preliminary proposal to the Township.

Supervisor Gray said any questions about the contract with Carrie Hancock should be directed to her. He also said a sub-committee is not a public body.

ITEM 5:11-15 CONTRACT AWARDS AND AGREEMENTS

A. Horse Farm House Demolition

Jay James, Building Official, advised the Board that two bids (Milford Salvage Iron and Metal in the amount of \$16,200 and RJ Hoffman Management in the amount of \$15,695) were received for the demolition of the residential house located at 2552 Wixom Road. The bid included the abatement of the asbestos material. He recommends the Township Board award the contract to the low bidder, RJ Hoffman Management Inc. in the amount not to exceed \$17,000.00 (Bid price of \$15,695.00 plus \$1,305.00 in contingency, if needed).

Trustee Weber – Ms. Hancock said she had contractors tell her that the house is structurally sound. Jay disagrees with what her contractors said. He said the ceiling has had a roof leak for decades which caused it to collapse and is falling down onto the main floor which is causing that to decay also.

Trustee Sovel asked if both contractors have the proper insurance. Jay answered yes.

Trustee Weber asked if both contractors included the asbestos abatement. Jay answered yes.

Trustee Magner asked if there was anything in the house that Ms. Hancock would need to remove. Jay answered not that he is aware of, however he will contact Ms. Hancock prior to demolition and ask her.

MOTION by Weber, supported by Phillips, to award the contract for the demolition of the residential house located at 2552 Wixom Road to the low bidder, RJ Hoffman Management in the amount not to exceed \$17,000.00 (Bid price of \$15,695.00 plus \$1,305.00 in contingency). A meeting will be held to discuss the demolition. Supervisor Gray shall have the option to pause demolition and revisit it based on the outcome of the meeting.

B. Resolution Adopting Revised Procedures for Electronic Meetings and Attendance

Hans Rentrop, Township Attorney, reminded the Board that in December 2020, the state legislature amended Section 3a of the Open Meetings Act ("OMA") to expand the reasons permitting remote attendance by members of a public body to accommodate members who were absent because of medical reasons or other reasons related to the COVID-19 pandemic. In January 2021, the Township Board adopted "Procedures for Electronic Meetings and Attendance" to reflect the 2020 amendments and procedures. These COVID-19 related accommodations expired under the OMA on December 31, 2021. He recommends the Board update the Township Board's Procedures to 1.

Enclosed for your consideration is an engagement letter from a Texas-based law firm, M.E. Heard, Attorney, PLLC, who has agreed to assist the Township with filing a claim with the Southern District of Texas Bankruptcy Court to secure the Township's interests in unpaid property taxes. He recommends the Board approve the terms of engagement proposed and direct Molly Philips to execute the same.
